

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.tyeshiasturgis.com, and Tyeshia Sturgis and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Tyeshia Sturgis include www.tyeshiasturgis.com, Tyeshia Sturgis, T.L Sturgis and www.tyeshiasturgis.com. The Tyeshia Sturgis website is a blog, news and information, ecommerce site. By using the Tyeshia Sturgis website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Tyeshia Sturgis may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Tyeshia Sturgis's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. Use of your Personal Information

Tyeshia Sturgis collects and uses your personal information to operate and deliver the services you have requested.

Sharing Information with Third Parties

Tyeshia Sturgis does not sell, rent or lease its customer lists to third parties.

Tyeshia Sturgis may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Tyeshia Sturgis. Use of Cookies

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
